- 2. Treasurer's Report See Appendix A below.
- 3. Committee changes Amy Bauer and Randy Moore, both from LCDC, are graciously helping out with 10CDDC Communications. Amy is dealing with social media, and Randy is our new webmaster. Tim Buchholz has resigned from the Committee. We will ask Local Committees to announce an opening, with the caveat that we will likely pick another male from Loudoun. We will hold a vote at the November meeting to fill the opening.

- 4. Status of training for county/city chairs Shelley Pre-Reorg Training to be scheduled between Election Day and Thanksgiving for folks contemplating running for an officer position at Reorg.
- 5. Status of 2019 fundraising plan Zach Jay has been running fundraising calls weekly.
  - a. Annual Herring and Hovis Award Event. Won't be as large as the last two years, but is on track to do okay.
  - b. Smaller fall event. Due to the large number of campaigns and other fundraising events this cycle, plus the moderate response to the Awards event, we will skip having a second event.

Collaborate with Grass Roots Organizations Karen Due to issues with the one planned for the Manassas area, and the lateness of this plan, we are skipping the 2<sup>nd</sup> event; attendees would be expected to be mainly campaign personnel and volunteers, who should be out canvassing. For the Winchester one, all invited candidates have accepted the invitation to participate. It will be Sept 28 at James Wood Middle School in Winchester from 1-3:00 pm.   - b. Recommendations for 2019 spending by team formed to evaluate this. (Team = Kimberly Adams, Tim Buchholz, Karen Campblin, Jerry Foltz, Jay Frost, Ellen Heald, Heidi Zollo) Karen Haven't been able to schedule a meeting due to conflicts. Zach has already set us up for Facebook ads, but not Twitter or YouTube ads. YouTube requires more graphics design and video. Two components to anything we do: money and volunteer time. MOTION Koran Saines, 2<sup>nd</sup> Clara Meagher Pay for a Facebook ad to remind folks about the Election and ask them to click through to candidate info PASSED. Dollar amount will be settled later via email or telecon. Karen Campblin & Koran Saines to work with Webmaster Randy Moore to get precinct lists for non-Loudoun jurisdictions. Meeting needed in early October to determine final spending decisions.

- 11. Reorgs Be prepared to attend Reorgs of other jurisdictions. Schedule will be known mid-November, and then we can create a sign-up. Ideally we should have two observers from another jurisdiction at each Reorg. Zach Be prepared to sign-up as soon as we have the list set up mid-November.

Zach –The ban on incumbents picking the nominating process is still in Federal Court, and the injunction is still in place, so currently it's up to us to choose. Please study the methods to refresh your memories and talk to your activist groups about preferences. Zach will follow-up on campaign finance rules in the event of a non-contested primary...he has heard rumors that there is a financial advantage to using a non-Primary process. Matt Leslie explained that the Primary fundraising season opened the day after the 2018 election, so the advantage of switching to General Election fundraising sooner than the June Primary date is that maxed out donors can start donating again.
