**NEW BUSINESS**

8. Special election in HD29 – **Filing deadline Aug 14 at 5:00 PM. Irina Khanin has announced she's running. Nominating process has been determined – electronic firehouse primary using the DPVA software. The special election will be held Nov 3.**
9. Spending ideas for money raised thus far:
  - a. **Due to the possibility of an in-person convention in May 2021, we should leave \$3,500 in the bank for next year. So we have \$15,000 to spend.**
  - b. **Donate \$5,000 to Wexton. The 5K limit applies to all Dem committees combined.**
  - c. **Yard signs.**
  - d. **Last year we hired a staffer, but we can't send someone canvassing, so this might be problematic this year.**
  - e. **Around 20 candidates are running within CD10.**
    - i. **Special Elections**
      1. **HD29 (Irina Khanin has announced) – Jerry suggests \$5K to this race to try to win another seat.**
      2. **Clarke County BOS, Berryville District (no Dem has filed)**
      3. **Frederick County BOS, Shawnee District (Dem nominee = Richard Kennedy)**
    - ii. **Stephens City (2 unopposed)**
    - iii. **Manassas/Manassas Park (Mayor + 3 Council members for each city)**
    - iv. **Winchester (Mayor + 4 Council members)**
    - v. **Leesburg (Mayor + 3 Council members)**
  - f. **Encourage absentee voting.**
  - g. **Absentee chasers. (\$\$ to local committees to support theirs)**
  - h. **Digital ads. (Spent \$2-3K last year.)**
  - i. **Texting. (LCDC is getting a 4 cents/text price)**
  - j. **Voter Registration support.**

**MOTION - Order 4,000 of the two color signs immediately, 2<sup>nd</sup>. Amendment to change number to 3,000, 2<sup>nd</sup>. Vote on amendment FAILED. Vote on original motion FAILED.**

**MOTION – Order 4,000 of the two color signs, but wait for Vice Presidential name and potential redesign, and vote by email on redesign; if we don't have anything by Saturday Aug 8, order the current design, 2<sup>nd</sup>, PASSED. Winchester/Frederick want 500 and have offered to fund them.**

**Changes needed to the sign design: Authorization spelling correction; authorization statement blue; lose the exclamation point.**

**MOTION – Donate \$2,000 to the Democratic nominee for HD29, 2<sup>nd</sup>. Amendment to change amount to \$1,000, 2<sup>nd</sup>. Accepted as a friendly amendment. Vote on motion as amended to \$1,000, PASSED.**

**MOTION – Donate \$5,000 to the Wexton Campaign, 2<sup>nd</sup>, PASSED.**
